RESOLUTION NO. 5 OF 2006

INCREASING SEWER USER RATES

WHEREAS, at a regular meeting of the Fairchance Georges Joint Municipal Sewage Authority, hereinafter called "Authority", called for general business purposes on August 14, 2006, the Authority authorized increasing sewer user rates for residential and commercial customers; and,

WHEREAS, said regular meeting was advertised according to the laws of the Commonwealth of Pennsylvania and notice thereof was provided; and

WHEREAS, said regular meeting was open to the public and in all respects complied with the Pennsylvania Sunshine Act.

NOW THEREFORE, be it resolved as follows:

The Fairchance Georges Joint Municipal Sewage Authority passed a motion increasing sewer user rates beginning with the November 1, 2006 bill as follows:

Residential	\$ 35.00 per month
Business	\$ 40.00 per month
Beauty Salons	\$ 50.00 per month
Bars	\$ 87.50 per month
Industrial and Commercial	\$ 45 .00 per EDU per month
Vacant	\$ 8.00

Apartments will be bill \$35.00 per unit. In structures where there is only one water meter and no way to terminate water service to each apartment, each unit will be billed as occupied. This motion was made by Dennis Eicher, seconded by Mr. Laubham and unanimously carried.
